**GENERAL INSTRUCTIONS TO THE CANDIDATES SHORTLISTED FOR INTERVIEW FOR THE POST OF  
TECHNICIAN-B (FITTER - POST NO. 1251)**

1. You are eligible to attend the interview only if you fulfill the following conditions :
  - a. Essential qualification :
    1. SSLC/SSC Pass.
    2. ITI/NTC/NAC in Fitter Trade.
  - b. Maximum Age limit :  
35 years for UR category as on 05.09.2014. 38 years for OBC category & 40 years for SC category. [Ex-servicemen & Persons with Disability are eligible for age relaxation as per rules.]
2. You are required to duly fill-in the downloaded **BIODATA FORMAT** in all respects and produce the **ORIGINAL** and self-attested copies of **Certificates, mark lists and testimonials in respect of your qualifications, experience, caste (latest OBC non creamy layer certificate in the case of OBC candidates and latest SC certificate in the case of SC candidates), Physical Disability certificate (for Hearing Handicapped & Visually Handicapped category with minimum 40% disability), discharge book (for Ex-servicemen category) & age** without which you will not be allowed to attend the interview. OBC candidates are required to produce the non-creamy layer certificate in the format given in the link provided below:

3. You may note that any request for change of date of interview will not be entertained.
4. **Those candidates who qualify in the interview will have to undergo Trade Test either on the same day or on the following day of interview. Therefore, please note that you may have to stay for the next day also, if required, at your own expenses.**
5. Outstation **SC/ST candidates** who appear for the interview will be reimbursed to and fro sleeper class rail fare by shortest route between the place mentioned in the web application and the place of interview (Thiruvananthapuram) on production of proof of travel. In case of travel by bus, the actual fare paid or second-class train fare, whichever is less will be reimbursed. If you travel by bus, you have to produce the bus ticket(s) and if you travel by train, you have to furnish the train ticket(s).
6. If you travel from a place other than the one already declared in the web application, TA will be paid from the actual place of journey or from the place declared in the web application, whichever is the shortest. Any change in the place of residence may please be intimated well in advance. You will not be paid TA from the changed address, unless it is intimated in writing [either by letter/fax/e-mail] well in advance.
7. If you are at present an employee of a Government/Semi Government Organisation/Autonomous or Public Sector Undertaking/Private Organisation aided by Government, please produce a **NO OBJECTION CERTIFICATE** from your present employer at the time of interview, **without which you will not be interviewed.**
8. **It may please be noted that you need to attend the interview, only if you possess the required qualification, age etc., as mentioned in your web application and could produce the Original Certificates in proof at the time of interview. In case it is found that any information furnished in your web application is wrong, your candidature will not be considered for the interview and no TA will be paid.**
9. If selected, you will have to resign from the present employment and join this Organisation as a fresh entrant.
10. Canvassing in any form will be a disqualification.
